Sri A Ramprasad, asked the Principal regarding the tentative date for the submission of the IIQA to NAAC. Principal redirected the question to Smt.Srilakshmi V Kittur, wherein the explanation given were as follows:

IQAC Coordinator Smt.Srilakshmi V Kittur's explanation-

- The preparation from the IQAC team consisting of 6 criteria members and IQAC coordinator are in right direction and are under the proper guidance provided by the external advisor, who provided his guidance during the lockdown period on each criteria weekly once.
- They are also guided by the NAAC Manual and regular meeting among themselves by exchanging the ideas and views and suggestions and certain difficulties in their work.
- The same convened to the IQAC coordinator and NAAC Coordinator who in turn has bought it to the notice of the Principal as and when it was raised.
- Principal in the seat provided the possible suggestions and advice in the respective issues.

- Mr. Shankar K, mentioned that the major drawback was the frequent change in the
 criteria members and college committee member due to their non-availability, led to
 the missing of important documents for records.
- It was also bought to the notice of the General Secretary that no easy access was given
 to the IQAC team in maintaining the records that are solely required for NAAC
 purpose to which Sri A R Acharya vehemently informed the Principal that it should
 not happen and next time if any documents are asked for it should be available in the
 IQA Cell.
- It was also informed that the delay in the submission of the IIQA was due to change
 in the authorities of the college and lack of certain activities in the college which is of
 major concern.
- Many proposals form IQAC were given to the authorities for conducting the activities
 and other things but there is neither no response nor action taken. For Which Sri
 Ramprasad sir suggested to send a mail to the college and keep the record of the
 same.
- Website of the college- explanation provided by the IQAC coordinator- The college website was designed by Ex-Vendor (Embassy Solution) and almost all the major aspect of the website was ready, wherein only the final touch-up was needed it was withdrawn from them and was assigned to the new vendor, (Mr. Sunil of 5ine Info Tech Solutions) there seemed to have been some internal issues in the new Vendors office and that impacted a big delay and pause in the website designing process. Sri A R sir suggested to write directly and strongly and check with the vendor regarding this and vehemently get confirmation whether they would be interested in providing their service.
- As far as the other document/records/reports are concerned they were provided timely
 by the Office Staff, Committee Conveners and Departments like Library, Commerce,
 Management, PG.
- COVID also was one of the main reasons for the delay in submission of IIQA, wherein the extension was given by NAAC authorities, was major reason for slowdown of the work.
- As far as AQARs are concerned all the 5 years AQARs were submitted on time on the NAAC Portal.
- IQAC Coordinator also bought to the notice of the General Secretary and Academic Committee Member and NAAC Advisor regarding the participation in the National Ranking Framework of MHRD, which was appreciated by them.
- IQAC also assured that before the mid of March we will go for accreditation and try
 to get the best grading for the college.

Certain other issues like Industry Representation in the IQAC Committee – Sri A R Sir suggested the names of certain members.

Smt. Srilakshmi V Kittur welcomed the members to the meeting with the permission of the Chair and Principal.

Principal, Dr. B Paramesha introduced the members present to the chair and also appealed Dr. Ramaprasad to give guidance and advice on the NAAC Accreditation process.

Agenda: 1

Preparedness for NAAC Accreditation:

Dr. A Ramprasad(ARP) directed the members to present their respective Criteria status and give updates and information on the same.

Criteria1-: Smt.MandasmithaN, Convener explained the members present about the criteria as the key metrics it was given to understand from her presentation that almost all the required aspects of criteria -1 are met with but there are few metrics which are yet

needs to be prepared like the Analysis of the feedback on syllabus and teachers. It was also bought to the notice of the Chair that there were two ADD-ON certificate courses which were conducted in these 5 years and the details of the same are documented and maintained.

When asked by the sri. ARP regarding the marks expected- it was guessed that perhaps 70-80 can be expected on 100

Criteria- 2:Convener, Mr. Rajumuthu, started his explanation that this criterion carries about 350 marks and 7 key metrics are there in that, 2.2.1 which talks about "The institution assesses the learning levels of the students and organises special programmes for advanced learners' ad slow learners' which needs to be prepared yet and for which the Chair (ARP) also suggested that he will give the format for the same.

It was suggested by the Cahir under metrics 2.3.2 "Teachers use ICT enabled tools for effective teaching learning process" the college to apply for licence for on-line learning like Swayam, Coursera, Eduex, NAPTEL so that students are doing those course simultaneously along with their main course.

2.3.3"Ratio of Mentor to students for the academic and other related issues" is not yet ready and a common/standard Mentor-Mentee meeting format to be used whichincludes:

- Student updated
- Reasons of absence if ay
- Standard of learning
- Level of understanding
- Any other issues other than academics

It was suggested in the meeting a 52" monitor TV to be installed in the library or some identified place so that the students who come late and cannot make it to the calls can have online lesson there.

Criteria-3: -Smt.Shilpa V gave the updates regarding this and said that she has collected all the required document for the criteria and will arrange according to the standard format as prescribed by NAAC.

It was also mentioned by her that only almost all the teachers have published their papers but only 2 faculties have the impact factor (Smt.Srilakshmi V Kittur and Mr. Arjun) Mr. Arjun has the H-index also. As Research, innovation and Extension was the compliance factor in the previous accreditation, there is a lot of improvement in the same. It was suggested in the meeting to collect MoU with BM Narayan Hospital from the Trust Office which is functional. Furthermore, it was also recommended to conduct IPR related sessions.

Criteria-4: - Ms. Darshini V, as per the criteria metrics all the required and supporting documents have been collected like the blue print, bills, AMC etc.

The only concern is the Bandwidth and the website of the college, as far as bandwidth is concerned there is 20MB bandwidth(BSNL) is there but it is not even giving 6-7 also and college website is not yet ready due to some issues from the Vendor's side.

Language Lab is not functioning though it is setup by the English Department in 2019 itself, all the required equipments required, like 30 systems and headphones have already been acquired it is not in use.

Convener was expecting 70-80 on 100 for this criteria.

Criteria-5: - Mr. Shankar is heading this Criteria as per the updates given the concerns are mentoring and alumni engagement of metric no., 5.4.1 and 5.4.25.4.1 there are some supporting documents but 5.4.2 there are absolutely no such contributions during the last five years. So it's better to opt out of the same. Principal also seconded his opinion of opting out of the same.

80-90 on 140 is what is expected.

Criteria-6:- Smt. Srilakshmi V Kittur –Vision and Mission, Strategy development and deployment, Faculty Empowerment strategies in that 6.3.1 there is no such welfare measure provided to the faculties, so it's better to opt out of the same.

6.3.3 Can also be opted out and other metrics are met with as per the requirement of the key metrics of Criteria-6, so on 100, 65-70 can be expected.

Criteria-7: -Dr.Channamaraiah showed his preparedness of 7.1 that is Institutional Values and Social responsibilities which the college have to some extent like safety and security, counselling and women empowerment cell and its interesting activities.

Green Audit Report conducted in the college is also made available by the IQAC.

- 7.2 Best practices it was identified that
- 1) Fees concessions to the need and meritorious students.
- 2) NSS activities-especially adopting a remote village near by Bangalore for about a week and conducting various awareness. Guest lectures, yoga shibir and entertainment programs, involving the natives of that village.
- 3) IOAC has initiated a regular YOGA as the curriculum of the college.
- 7.3 Institution Distinctiveness needs to be prepared.
